DEDICATED LOADS:

- I. Load(s) that a shipper or registered/licensed property broker will have on a continual or seasonal basis.
- II. DISPATCH COMPANY books CARRIER on such load(s) and CARRIER agrees to move the load(s).

NO BACK SOLICITATION:

- I. CARRIER shall not directly or indirectly solicit, divert, back-solicit, or perform any dedicated freight transportation (with or without compensation) for any shipper or property broker when such dedicated freight was originated as a direct result of the effort of DISPATCH COMPANY for a period of twelve (12) months. Transportation of dedicated freight hereunder by CARRIER shall be deemed conclusive evidence of CARRIER's transportation service to J.B. Raptor Logistics, LLC's direct shippers or registered/licensed property brokers.
- II. In the event of breach of this provision, J.B. Raptor Logistics LLC shall be entitled, for a period of 12 months following delivery of the last shipment transported by CARRIER under this Agreement, to a fee of twenty percent (20%) of the gross transportation revenue (as evidenced by freight bills) received by CARRIER for the transportation of said freight as liquidated damages. Additionally, DISPATCH COMPANY may seek injunctive relief, and, in the event, it is successful, CARRIER shall be liable for all costs and expenses incurred by DISPATCH COMPANY, including, but not limited to, reasonable attorney's fees.
